Contributions may qualify you for a tax credit on your federal income tax return as illustrated below.

In accordance with Government's Federal Accountability Act, Coast of Bays-Central-Notre Dame Conservative Association contributions from individual Canadian citizens or permanent residents to a maximum of \$1725 per calendar year.

Tax receipts can only be issued in the name of the contributor and the contributor is considered to be the holder of the credit card or the signatory on the cheque. Please note that contributions from corporation, labour unions or associations, and unincorporated associations are prohibited by Elections Canada.

Payment by cash, pre-paid credit card, money order (unless from a Canadian financial institution), corporate cheque or corporate credit card is not permitted.
